A motion to pass the amendment to section 11 of the by-laws was made by Beverly Sharpe with the 2nd by Blake Griffin. The amendment was passed. A vacancy is to be

filled either by the next high vote received in the previous election for the position, or by appointment if the next high vote receiver can not fill the term.

The amendment to section IV A of the laws concerning missed meetings and membership was returned to the By-Laws Committee. Language about proxies and removal from the council were to be removed.

An amendment to Section IV B 2 of the laws to rename the Elections Committee was rejected. The council voted to change the name of the Elections Committee to Communications/Elections Committee and there would be no change of duties.

#### 8. Other Business

The Kids Night Out Program being offered by Student Activities was discussed. Most council members thought it would be good for this to include the children of staff even if it involved a small personal cost.
